

# 2010 Faribault County Fair Demolition Derby

Saturday, July 24, 2010 - Demo will be starting at 7:30 PM  
Pits open at 4:00 p.m. Car cut-off at 6:30 p.m.

**FULL-SIZE COMPETITION:** The entry form and registration fee should be completed and mailed by July 9, 2010. If the entry form is received by July 9<sup>th</sup>, the registration fee is \$40. Entry forms that are received after July 9<sup>th</sup>, the registration fee will be \$50.

**PAYOUT:** 1<sup>st</sup> Place - \$1200.00 and Trophy      4<sup>th</sup> Place - \$250.00  
                 2<sup>nd</sup> Place - \$800.00 and Trophy      5<sup>th</sup> Place - \$150.00  
                 3<sup>rd</sup> Place - \$500.00 and Trophy

Drivers who participate in the Feature will **NOT** be reimbursed their entry fee.

**CONSOLATION COMPETITION:** A Consolation heat will take place based on driver interest. The top three places in the Consolation Competition will advance to the Feature Competition. To be eligible for the Consolation Competition, you must participate in your assigned heat.

**COMPACT CAR COMPETITION:** If the entry form is received by July 9, 2010, the registration fee is \$40. Entry forms that are received after July 9<sup>th</sup>, the registration fee will be \$50.

**PAYOUT:** 1<sup>st</sup> Place - \$600.00 and Trophy  
                 2<sup>nd</sup> Place - \$350.00 and Trophy  
                 3<sup>rd</sup> Place - \$225.00 and Trophy  
                 4<sup>th</sup> Place - \$150.00  
                 5<sup>th</sup> Place - \$50.00

**TRUCK (½ to 1 ton plus suburbans) COMPETITION:** Most of the rules are the same as the cars with a few additional rules added. If the entry form is received by July 9, 2010, the registration fee is \$40. Entry forms that are received after July 9<sup>th</sup>, the registration fee will be \$50.

**PAYOUT:** 1<sup>st</sup> Place - \$800.00 and Trophy  
                 2<sup>nd</sup> Place - \$400.00 and Trophy  
                 3<sup>rd</sup> Place - \$275.00 and Trophy  
                 4<sup>th</sup> Place - \$150.00
